

The goods shall be complied with the Packing Instruction 965~967 of IATA DGR 58th Edition for transportation, including the passing of the UN38.3 test, And also complies with the Special Provision 188 and 230 of IMDG CODE (Amdt.38-16) 2017 Edition.

The batteries should be securely packed and protected against short-circuits. Examine whether the package of the containers are integrate and tighten closed before transport. Take in a cargo of them without falling, dropping, and breakage. Prevent collapse of cargo piles. Don't put the goods together with oxidizer and chief food chemicals. The transport vehicle and ship must be cleaned and sterilized otherwise it is not allowed to assemble articles. During transport, the vehicle should prevent exposure, rain and high temperature.
