The goods shall be complied with the requirements of 62nd DGR Manual the Packing Instruction 965-967, Section IB or II of IATA (2021 edition), including the passing of the UN38.3 test, And also complies with the Special Provision 188 and 230 of IMDG CODE(Amdt.39-18) 2018 Edition.

The batteries should be securely packed and protected against short-circuits. Examine whether the package of the containers are integrate and tighten closed before transport. Take in a cargo of them without falling, dropping, and breakage. Prevent collapse of cargo piles. Don't put the goods together with oxidizer and chief food chemicals.
